REEL 'EM IN FOR ROTARY CHARITY BASS TOURNAMENT

RULES AND REGULATIONS

- 1) LIFE JACKETS MUST BE WORN AND KILL SWITCH MUST BE USED AT ALL TIMES WHEN BOAT IS ON PLANE.
- 2) TOURNAMENT OFFICIALS HAVE THE RIGHT TO REFUSE AN ENTRY FORM FROM ANYONE.
- 3) ALL BOATS WILL BE INSPECTED BEFORE TAKE OFF.
- 4) ORDER OF TAKEOFF WILL BE DETERMINED BY WHEN REGISTRATION RECEIVED.
- 5) FIVE FISH LIMIT. NO MINIMUM NO MAXIMUM. AT NO TIME SHALL ANY TEAM HAVE IN THEIR POSSESSION MORE THAN THE TOURNAMENT LIMIT OF 5 FISH. CULLING FISH MUST BE DONE IMMEDIATELY UPON CATCHING THE 6th FISH. CULLING OF DEAD FISH WILL RESULT IN IMMEDIATE DISQUALIFICATION.
- 6) DEAD FISH – EVERY DEAD FISH WILL RESULT IN ONE-HALF POUND (8 OUNCES) PENALTY FROM TOTAL WEIGHT. MORE THAN THREE (3) DEAD FISH RESULTS IN DISQUALIFICATION.
- 7) A DEAD FISH CANNOT WIN THE BIG BASS POT.
- 8) WEIGH-IN TIME BEGINS AT 2PM, CHIP MUST BE ON BOARD AT WEIGH-IN SITE. NO WEIGH IN BEFORE 2PM.
- 9) LATE BOATS: 8 OZ PENALTY PER MINUTE UP TO FIVE (5) MINUTES. AFTER FIVE MINUTES YOU ARE DISQUALIFIED.
- 10) IN CASE OF A TIE – BOTH PLACES WILL BE JOINED, TOTAL MONIES WILL THEN BE SPLIT.
- 11) NO TROLLING WITH BIG MOTOR OR ELECTRIC MOTOR.
- 12) ANY INTERPRETATIONS OF THE RULES OR RULING WILL BE THE DECISION OF THE TOURNAMENT DIRECTOR. THE TOURNAMENT DIRECTOR'S DECISION IS FINAL.
- 13) ANY COMPETITOR AGE OF 16 AND UNDER MUST HAVE PARENTS SIGNED CONSENT TO FISH THIS EVENT OR BE ACCOMPANIED BY AN ADULT.
- 14) PROTESTS: ALL PROTESTS SHALL BE BROUGHT TO THE ATTENTION OF THE TOURNAMENT DIRECTOR. ALL PROTESTS MUST BE IN WRITING AND TURNED IN TO THE TOURNAMENT DIRECTOR NO LATER THAN 30 MINUTES AFTER START OF OFFICIAL WEIGH-IN. IF NOT, THE PROTEST WILL BE CONSIDERED INVALID. THE DECISION OF THE TOURNAMENT DIRECTOR AND HIS/HER STAFF IS FINAL.

BREAK DOWN: IF YOU BREAK DOWN AND CANNOT CONTACT ANOTHER TOURNAMENT BOAT AND CANNOT MAKE YOUR CHECK IN TIME YOU WILL BE DISQUALIFIED. IF YOU CONTACT ANOTHER TOURNAMENT BOAT, ONE PARTNER CAN TRANSPORT THE TEAM'S FISH TO WEIGH-IN.

RELEASE OF LIABILITY
